The Ratts 1 Solar Project is a 150 megawatt (MW) solar field planned near Petersburg. The project has secured all necessary approvals and is preparing for the construction phase. The Ratts 1 Solar Project will employ up to 350 people within Pike County. Once complete, the solar field will produce enough electricity to power 28,000 Indiana households annually and will operate for 35 years. Arevon and Tenaska are working together on 8,000 MW of solar projects across the United States, including five projects in southern Indiana.
